### 3.2 The relation between Lagan and Navmash chart

The Lagan chart and Navmash chart gets finalized for a newly born child or the native at the time of his birth, based on his birth details i.e. birth time (am/pm), date, month, year and location. However, we have observed that Lagan and Navmash chart completely coordinate to determine and govern the life and its major events. Lagan chart of the native lays the foundation of the life and works till the age of thirty four whereas Navmash chart represents the second half of the life that casts its effect from thirty fifth year and thereafter figure 2.
